5:20 pm WCBS Announces WTC 7 Might Have Collapsed Seconds Before It Collapses Live

5:21 pm WTC 7 collapses in 7 seconds in a symmetrical fashion into its own footprint with pyroclastic-like dust clouds

Security in high rise buildings is very thorough. Prepping the towers would have taken a lot of time. There was a 9 month elevator modernization program going on. CIA analyst, Susan Lindauer, states that video cameras show trucks coming to WTC every night from Aug. 23rd after 3am when cleaning and maintenance personnel had left.

No evidence of massive amount of debris from 100 ton plane with two 6 ton titanium & steel engines
